KNOW ALL MEN BY THESE PRESENTS, That _____

act as authorized agent for export control , U.S. Census Bureau (Census Bureau) reporting, and U.S. Customs and Border Protection (CBP) purposes.

Also, to prepare and transmit any Electronic Export Information (EEI) or other documents or records required to be filed by the Census Bureau, CBP, the Bureau of Industry and Security, or any other U.S. Government agency, and perform any other act that may be required by law or regulation in connection with the exportation or transportation of any goods shipped or consigned by or to the USPPI, and to receive or ship any goods on behalf of the USPPI.

USPPI authorizes the above authorized agent to act within the territory as lawful agent and sign or endorse export documents (i.e., commercial invoices, bills of lading, insurance certificates, drafts and any other document) necessary for the completion of an export on USPPI's behalf as may be required under law and regulation in the territory and to appoint forwarding agents on USPPI's behalf.

The USPPI hereby certifies that all statements and information contained in the documentation provided to the authorized agent and relating to exportation will be true and correct. Furthermore, the USPPI understands that civil and criminal penalties may be imposed for making false or fraudulent statements or for violation of any United States laws or regulations on exportation.

This power of attorney is to remain in full force and effect until revocation in writing is duly given by the U.S. Principal Party in Interest and received by the Authorized Agent.

USPPI acknowledges receipt of **Green Worldwide Shipping, LLC's** Terms and Conditions of Service governing all transactions between the Parties. If the USPPI is a Limited Liability Company, the signatory certifies that he/she has full authority to execute this power on behalf of the USPPI.
