# 10 + 2 REQUIRED ELEMENTS

# MANUFACTURER (OR SUPPLIER) NAME & ADDRESS

Name and address of theentity that last manufactures, assembles, producesor grows the commodityor name and address of the supplier of the finished goods in the countryfrom which the goods are leaving. In the alternative, thename and address of themanufacturer (or supplier) that is currentlyrequired by the import laws, rules and regulations of the United States (i.e., entryprocedures) may be provided (this is the information that is used to create the existing manufacturer identification (MID) number for entry purposes).

## SELLER NAME & ADDRESS

Name and address of thelast known entityby whom the goods aresold or agreed to be sold. If the goods are to be imported otherwise than in pursuance of a purchase, the name and address of theowner of the goods must be provided. (The party required forthis element is consistent with the information required on the invoice of imported merchandise.

## **BUYER NAME & ADDRESS**

Name and address of thelast known entityto whom the goods aresold or agreed to be sold. If the goods are to be imported otherwise than in pursuance of a purchase, the name and address of theowner of the goods must be provided. (The party required for this element is consistent with the information required on the invoice of imported merchandise.)

## SHIP TO NAME & ADDRESS

Name and address of the first deliver-to party scheduled to physically receive the goods after the goods have been released from customs custody.

#### CONTAINER STUFFING LOCATION

Name and address(es) of the physical location(s) where the goods were stuffed into the container. For break bulkshipments, then ame and address(es) of the physical location(s) where the goods were made "ship ready" must be provided.

# CONSOLIDATOR (STUFFER) NAME & ADDRESS

Name and address of theparty who stuffed the container or arranged for the stuffing of the container. Forbreak bulk shipments, the name and address of the party who made the goods "ship ready" or the party who arranged for the goods to be made "ship ready" must be provided.

### COUNTRY OF ORIGIN

Country of manufacture, production, orgrowth of the article, basedupon the import laws, rules and regulations of the United States.

#### COMMODITY HTSUS NUMBER

Duty/statistical reportingnumber under which the article isclassified in the Harmonized Tariff Scheduleof the United States (HTSUS). The HTSUS number is required to be provided to thesix-digit level. The HTSUS number maybe provided up to the 10-digit level.
